What data do we collect?

Our company collects the following data:

- Personal identification information where voluntarily provided (name, email address, phone number, etc)
- Information about your computer or any other electronic device which you use to access our website (your IP address, browser, etc)

How do we collect your data?

You directly provide Cema Vending with most of the data we collect. We collect data and process data when you:

- Complete an online form
- Use or view our website via your browser's cookies

How will we use your data?

Our company collects your data so that we can:

- Process your orders, manage your account
- Email you with special offers on other products and services we think you might like
- To identify which pages you're using to help us analyse data about our web page traffic and allow us to improve the website

How do we store your data?

Cema Vending securely stores your data at Unit 5 Pintail Close, Victoria Business Park, Nottingham, NG4 2SG on a password protected computer in a lockable office

If you have agreed to receive marketing, you may always opt out at a later date

You have the right at any time to stop Cema Vending from contacting you for marketing purposes

What are your data protection rights?

Cema Vending would like to make sure you are fully aware of all of your data protection rights.

Every user is entitled to the following:

The right to access – You have the right to request Cema Vending for copies of your personal data.

The right to rectification – You have the right to request that Cema Vending correct any information you believe is inaccurate. You also have the right to request Cema Vending to complete information you believe is incomplete.

The right to erasure – You have the right to request that Cema Vending erase your personal data, under certain conditions

The right to restrict processing – You have the right to request the Cema Vending restrict the processing of your personal data, under certain conditions

The right to object to processing – You have the right to object to Cema Vending's processing of your personal data, under certain conditions

The right to data portability – you have the right to request the Cema Vending transfer the data that we have collected to another organisation, or directly to you, under certain conditions
